

# THE NAVAL REVIEW

**AIM - To promote the advancement and spreading within the Service of knowledge relevant to the higher aspects of the Naval Profession.**

## REGULATIONS OF THE NAVAL REVIEW

1. In order to encourage freedom of discussion and criticism, and ensure that diffidence arising from lack of seniority or inexperience of writing for publication shall not discourage participation in them, original contributions may be anonymous, the identity of the writers being known only to the Editor - unless they themselves elect to append their names or initials.
2. For the same reason, and also in order that the freedom of discussion provided by the *Naval Review* shall not constitute a contravention of the Queen's Regulations concerning contributions to the public Press, it is necessary to confine the circulation of the *Naval Review* to its members.
- 3. Members are therefore requested to undertake that they will take proper care of their copies, that they will not allow them or their contents to be communicated to any persons not eligible for membership or to the Press; and that they will take every precaution against their being available or used for any political or propagandist purpose. These regulations are necessary not because the existence or contents of THE NAVAL REVIEW are secret or confidential, but in order to maintain its character, and preserve its usefulness as a medium for free discussion. Similar precautions also apply to the content of, and access to, the Private Members' pages of *The Naval Review* web-site ([www.naval-review.co.uk](http://www.naval-review.co.uk)).**
4. The *Naval Review* is issued quarterly, only sufficient copies being printed for circulation to members.
5. Original articles in keeping with the aim and character of the *Naval Review*, and Correspondence arising from the contents of the *Naval Review* or otherwise relevant to its purpose, are invited. Material for publication should, if possible, be typewritten, with double spacing and good margins. Matter should reach the Editor not later than the end of the first week of the month before month of publication viz. 7 December for February, 7 March for May, 7 June for August, and 7 September for November.

### **Security, style and copyright**

6. The responsibility for what is published in the *Naval Review* rests with the Editor, but members must ensure that their contributions adhere to current security regulations. Personalities should, of course, be avoided.
7. The *Naval Review* makes no claim on copyright of any material which it may publish; such copyright rests with the authors themselves. For this reason, and because to be independent the *Naval Review* must remain self-supporting, payment for work published is limited to meeting the costs of research, production and postage.
8. Once an issue of the *Naval Review* is more than ten years old, the restrictions on custody and quotation lapse. If desired, such issues may be given or sold to, for example, a library, a second-hand bookshop or an individual.

### **Eligibility**

9. The following are eligible for membership: officers under training, commissioned and warrant officers, active or retired, of the Armed Forces of the Crown and the Commonwealth, and their Reserves; also members of the Royal Corps of Naval Constructors, and officers of the RMAS and RFA Service; and civil servants of HEO and HPTO (and equivalent) grades and above, who hold or have held appointments in the Naval Commands, or appointments with a Naval Connection in the Ministry of Defence Headquarters or the Procurement Executive. # MEMBERSHIP

The Editor can admit other persons in touch with and interested in the Royal Navy.

The annual subscription is £30.00. It is due on 1 January each year after enrolment. On enrolment the following amounts are payable dependent on the number of issues of the *Naval Review* required during the year of enrolment:

For all four issues £30; for three issues £22.50; for two issues £15; for one issue £7.50. (officers under training, half above rates.)

N.B. The subscription is allowable against Income Tax as a professional expense for serving officers and for other members whose profession makes this appropriate.

**Payment** may be made:

- (a) preferably by Direct Debiting Instruction on a UK bank account using the form overleaf. When filled in, it should be sent with the enrolment form to the Secretary-Treasurer *together* with a cheque for the current year's subscription or part-subscription. If a member joins towards the end of a year and the Direct Debiting Instruction is not received before 15 November it will be too late for it to take effect on 1 January following; in this case the cheque should also include the subscription due on 1 January after joining.

or (b) by cheque, money order or postal order sent to the Secretary-Treasurer.

or (c) (for overseas members particularly) by credit card (Mastercard or Visa only). Such payments may be made by post (using the enrolment form), telephone or e-mail.
